3. Analysis

The samples were analyzed using Waters Acquity UPLC equipped with Xevo TQ MS (LC/MS/MS "Sauron").

For aqueous samples, unless otherwise indicated by a screening analysis or matrix observation, the sample volume was measured gravimetrically by the laboratory, and all contents spiked with Extraction Standard (ES). The samples were mixed well and centrifuged (if needed), and then extracted by SPE. If the extracts are discolored after initial SPE, ENVI-Carb cleanup procedure is used. Injection Standards (IS) were added prior to analysis.

Initial extraction batch analysis resulted in low ES recoveries. Samples were re-extracted and reported for all analytes of interest.

4. Calibration

In the initial calibration, the reported analytes exhibited R^2 of ≥ 0.99 .
